Dear Sir or Madam,

Scotland Gas Networks Metering Charges from 1st June 2021

Please find attached schedules showing the revised metering charges to be applied by Scotland Gas Networks plc (**SGN**) with effect from 1st June 2021. This notification is provided 3 months in advance of the effective date consistent with the notice period required in SGN's metering contracts¹.

In general, the changes from SGN's existing metering charges reflect an increase of 1.10% in respect of inflation.

Four of SGN's metering charges are subject to maximum tariff caps that have been set by Ofgem, the gas industry regulator, and are set out in SGN's gas distribution licence. This means that charges for these services must not exceed the tariff caps which are increased each year by inflation (RPI). The charges for these four metering activities set out in the attached schedule are consistent with this charge restriction.

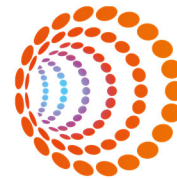

Transactional Charges

Any work downstream of the outlet of the meter is excluded unless specifically mentioned. In all cases, service pipe installation, alteration and disconnection and meter box provision is excluded and will be subject to additional charges.
